We have found from experience that students progress further and have more fun in small group lessons with peers. New students will receive a free 30-minute evaluation for placement in a class.

### Riding Program

Group Lessons:

Fees are paid on a trimester calendar. 60-minute group lessons (\$78.75 per lesson), \$945.00. (Lessons not in a program are \$85)

• Private Lessons

Fees are paid on a trimester calendar 30-minute private lessons (\$78.75 per person), \$945 (Lessons not in a program are \$85)

Each trimester is 12 lessons. The lessons must be completed within the 12-week period. We will work with you to fit in make-up lessons. It is the parents'/guardians' responsibility to arrange make-up lessons. When cancellations are due to the weather, the farm will contact you for make-up lessons. If students riding more than 1x per week, multiply trimester price by the number of days riding. IF WE CASH YOUR CHECK YOU ARE CONFIRMED. We will let you know via email your date and time. **Barn is closed on Fridays**

• All riders must wear a properly fitting helmet, boots with a heel, and long pants. We do recognize riding is an expensive sport and children grow quickly. We have a small exchange program for riding apparel that students have outgrown and a few pairs of boots at the barn that may be borrowed. (Riders will NOT be permitted to ride in shorts or sneakers) Initials\_\_\_\_\_

• Riders should allow 15 minutes before and after their lessons to help tack up, untack, and groom the horse. Initials\_\_\_\_\_

• We ask that you provide 24 hours' notice for any lesson which will be missed so that we can plan accordingly. Lessons that are not canceled with reasonable notice will not be made up.
